The Chief Electoral Officer, West Bengal, invites rates for carrying trunks containing Ballot Units and Control Units of EVMs inclusive of loading and unloading charges and all admissible taxes through e-tender as above, from resourceful Contractors/ Agencies/ Transporters including bona-fide outsiders & Govt. registered contractors/ agencies/ transporters having experience in same type of works. The EVMs will be transported in sealed trunks. Each trunk will contain 10 BUs/ 10 CUs or less.

#### **Preparation of Bids/Tender Documents:**

- a) Language of the Bid / Tender documents will be in English.
- b) Documents Comprising the Bid/ Tender documents.
   The Bid submitted by the Bidder shall be in two separate parts: Technical and Financial Bids

#### **Technical and Financial Bids**

Both **Technical Bid** and **Financial Bid** are to be submitted concurrently duly digitally signed in the website <a href="http://etender.wb.nic.in">http://etender.wb.nic.in</a>

Tender documents may be downloaded from website and submission of Technical Bid and Financial Bid will be done as per Time Schedule

The **FINANCIAL OFFER** of the prospective tenderer will be considered only if the **TECHNICAL BID** of the tenderer is found qualified by the 'Tender Evaluation Committee' formed by the Chief Electoral Officer and Principal Secretary to the **Government of West Bengal.** The decision of the 'Tender Evaluation Committee' will be final and absolute in this respect. The list of Qualified Bidders will be displayed in the website.

Bill of Quantity - The rates shall be quoted by the bidder entirely in Indian Rupees. Bidders will have to submit rates for trunks containing BUs and CUs and shall include rates for carrying trunks containing Ballot Units and Control Units of EVMs inclusive of loading and unloading charges and all admissible taxes/toll/Cess etc. In case of non-participation by any bidder, the specified space for quoting the rate must be kept Blank and in no situation, it is to be filled with Zero (0).

#### **Earnest Money:**

The scanned copy of the Bank Draft for Earnest Money will be required to be uploaded online by  $05.11.2015\ (2.00\ PM)$ . At the same time, the Bank Draft in itself must be received at this Office by 05.11.2015. It is important to note that both the online submission of the EMD and the physical receipt of the Bank Draft through registered post at this office are mandatory and both the conditions must invariably be fulfilled.

Apart from Disqualification and Rejection of tender the Earnest Money deposited by the bidder will be forfeited if they submit false/fake/forged documents in respect of Credential and Turnover.

#### Special Terms & Condition:

There will be no sub-letting of the Contract.

- 1. **Loading Point:** Trunks with BUs and CUs will be loaded in trucks from different warehouse points located in the district of Maharastra, Uttarakhand and Uttar Pradesh
- 2. <u>Unloading Point:</u> The trunk boxes are to be unloaded at the various locations spreading twenty one (21) districts across West Bengal, preferably to the district Head Quarters, within 15 (fifteen) days of receipt of the work-order.
- 3. **Proof of Delivery:** A receipt depicting details of delivery scripted with "received in good condition" with the receiver's signature and stamp is to be submitted along with the bills/challans.

- 4. Material lost in transit/Break down: Considering the importance and high security value of the loaded materials like EVMs, all precaution and preparedness shall have to be put on place by the Agency to ensure safe and secured passage of the materials up to the unloading point. The EVM trunk boxes are to be unloaded at the district Head Quarters in perfect condition as they were when loaded at the loading points at Maharastra, Uttarakhand and Uttar Pradesh with the seals of each boxes remaining intact. The transporting agency will hold complete responsibility for any damage caused or material lost in transit/break down and action will be taken as per existing norms and mandates of the Election Commission of India. No compromise will be made in providing security of the EVMs and any lapse will be viewed very sternly by the Authority.
- 5. **Details of vehicles carrying EVMs:** Details of vehicles carrying EVMs with truck no/drivers contact no/route maps along with a list of manpower for handling those materials are to be submitted to this end beforehand and no unauthorized handling will be accepted under any circumstance..
- 6. <u>Time-frame:</u> The works of loading, transportation and unloading of EVM trunk Boxes loaded with BUs and CUs are to be completed within 21 (twenty one) days from the date of receiving of work-order.
- 7. **Mode of Payment:** Payment will be made on receipt of the bills after successful completion of the work, i.e. transportation of EVMs from the warehouse points in Maharastra, Uttarakhand and Uttar Pradesh to respective districts in West Bengal in perfect condition. Payment to be made including service taxes and cess and all other levies as applicable after deducting TDS.
- 8. **Termination:** The office of the Chief Electoral Officer, West Bengal reserves the right to terminate the consignment without giving any reasons in case of failure to execute the contract or abide by any terms and conditions detailed herein.
- 9. **Arbitration:** In the event of any dispute or differences between the parties, the same shall be referred to the Arbitration before a Board of Arbitrators comprising one nominee from the transporting agency to be selected and the office of the Chief Electoral Officer, West Bengal and a presiding arbitrator before entering upon the references. The venue of such Arbitration shall be decided according to the conveyance of both the parties.
- 10. **Safety and Security:** Under no circumstance, the trucks will move without security as will be provided by the respective state police passing through the states of West Bengal, Odisha, Madhyapradesh, Jharkhand, Chattishgarh, Bihar, Uttar Pradesh, Uttarakhand and Maharastra etc.
- 11. An agreement will have to signed by the successful bidder with this office pledging adherence to the terms and conditions as above.
- 12. The bidder should submit a self-declaration that it has no previous history of arbitration, litigation, casting aspersions or causing accusations against the Government or its organizations.
- **13.** The participating agency is required to furnish an undertaking that it has no previous background of having defaulted while undertaking any previous work of the Government or its entities.

#### **Bid Submission Process**

#### INSTRUCTION TO BIDDERS

#### **General guidance for e-Tendering:**

Instructions / Guidelines for electronic submission of the tenders have been annexed for assisting the contractors to participate in e-Tendering.

#### **Registration of Contractor:**

Any contractor willing to take part in the process of e-Tendering will have to be enrolled & registered with the Government e-Procurement System, through logging on to <a href="https://wbtenders.gov.in">https://wbtenders.gov.in</a>. The bidder may also consult the website of the Chief Electoral Officer, West Bengal to view the NIT .

#### **Digital Signature Certificate (DSC):**

Each contractor is required to obtain a Class-II or Class-III Digital Signature Certificate (DSC) for submission of tenders from the approved service provider of the National Informatics Centre (NIC) on payment of requisite amount. Details are available at the Web Site above. DSC is given as a USB e-Token.

The contractor can search & download N.I.T. & Document(s) electronically from computer once he logs on to the website using the Digital Signature Certificate.

#### **Submission of Tenders:**

Tenders are to be submitted online to the website in two folders at a time for each work, one in Technical Proposal & the other is Financial Proposal before the prescribed date & time using the Digital Signature Certificate (DSC). The documents are to be uploaded which should be virus scanned and Digitally Signed. The documents will get encrypted (transformed into non readable formats).

#### **Technical Proposal:**

The Technical proposal should contain scanned copies of the following in two covers (folders).

#### (a) Statutory Cover Containing the following documents:

1) Demand Draft towards Earnest Money (EMD) as prescribed in the N.I.T. against each of the serial of work in favour of the **Chief Electoral Officer, West Bengal** payable at Kolkata . The DD will be returned to unsuccessful bidders after the tender process is over.

As the work performance guarantee, the successful bidder shall have to submit Bank Guarantee at the rate of 10% of the bid value in the name of the Chief Electoral Officer, West Bengal within five days of communication to this effect from the Chief Electoral Officer, West Bengal. In case of failure, to deposit bank draft within the stipulated period his earnest money shall be forfeited.

The **Chief Electoral Officer, West Bengal** reserves the right to reject or cancel any or all pre-qualification documents and bid document or the entire tender process without assigning any reason whatsoever.

2) N.I.T. (download properly and upload the same Digitally Signed). The rate will be quoted in the B.O.Q. Quoted rate will be encrypted in the B.O.Q. under Financial Bid. In case quoting any rate elsewhere other than the BOQ, the tender is liable to be summarily rejected.
