**NOTIFICATION**

NO. 464/WB-LA/2021 :— WHEREAS, the Governor of the State of West Bengal has, by a notification issued under sub-section (2) of Section 15 of the Representation of the People Act, 1951(43 of 1951), published in the official Gazette of the State on 2<sup>nd</sup> March, 2021 (Tuesday), been pleased to call upon each of the Assembly Constituencies in the State of West Bengal, as specified in column (1) of the Table below, to elect members of the Legislative Assembly of the State, in accordance with the provisions of the said Act and of the rules and orders made thereunder;

2. NOW, THEREFORE, in pursuance of Sections 30 and 56 of the said Act, the Election Commission of India, hereby—

- (A). appoints, with respect to the said election from each of the Assembly Constituencies specified in the said Table :—
- a) the 9<sup>th</sup> March, 2021 (Tuesday) : as the last date for making nominations;
- b) the 10<sup>th</sup> March, 2021 (Wednesday) : as the date for scrutiny of nominations;
- c) the 12<sup>th</sup> March, 2021 (Friday) : as the last date for withdrawal of candidatures;
- d) the 27<sup>th</sup> March, 2021 (Saturday) : as the date on which a poll shall, if necessary, be taken; and
- e) the 4<sup>th</sup> May, 2021 (Tuesday) : as the date before which the election shall be completed; and
- (B). fixes the hours, as shown in column (2) of the Table below, as the hours during which the poll shall, if necessary, be taken on the date specified above, in the corresponding Constituency shown in column (1) of the said Table :
