NOTIFICATION

No. 492/WB-LA/58/2021 – WHEREAS, for the purpose of holding of General Election to the Legislative Assembly of West Bengal, the Governor of West Bengal had, by Notification issued under Section 15 of the Representation of the People Act, 1951 (43 of 1951) and published in an Extraordinary issue of the State Gazette dated 31st March, 2021, called upon the 58-Jangipur Assembly Constituency in the West Bengal State to elect member to the said Legislative Assembly; and

WHEREAS, one validly nominated candidate, namely, Shri Pradip Kumar Nandi from 58-Jangipur Assembly Constituency set up by the Revolutionary Socialist Party, a recognized State Party of West Bengal, died on 16th April, 2021; and

WHEREAS, in consequence thereof and in accordance with the provisions of sub-section (1) of Section 52 of the Representation of the People Act, 1951, the Returning Officer for the said constituency adjourned the poll to a date to be notified later, and reported the fact to the Election Commission;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (2) of Section 52 read with Sections 30 & 56 of the said Act, the Election Commission of India, hereby –

(A) **appoints**, with respect to the said election from 58-Jangipur Assembly Constituency:

a) Last date for filling nomination by the candidate sponsored by Revolutionary Socialist Party only, in pursuance of Commission's Notice No. 492/WB-LA/58/2021, dated 19 th April, 2021	26 th April, 2021 (Monday)
b) Date for scrutiny of nomination of the candidate sponsored by Revolutionary Socialist Party, in pursuance of Commission's Notice No. 492/WB-LA/58/2021, dated 19 th April, 2021	27 th April, 2021 (Tuesday)
c) Last date for withdrawal of candidature by the candidate sponsored by Revolutionary Socialist Party only, in pursuance of Commission's Notice No. 492/WB-LA/58/2021, dated 19 th April, 2021	29 th April, 2021 (Thursday)
d) Date on which a poll shall be taken	13 th May, 2021 (Thursday)
e) Date before which the election shall be completed	18 th May, 2021 (Tuesday)

(B) **fixes the hours** from **7:00 AM to 6:30 PM**, as the hours during which the poll shall be taken on the date specified in Para (A) for the above said election.
