**NOTIFICATION**

No. 100/ECI/NOTI/TERR/ES-II/WB-LA/10/2019 :- WHEREAS, the seat of Shri Dilip Kumar Ghosh, in the Legislative Assembly of the State of West Bengal, elected from **224-Kharagpur Sadar Assembly Constituency** has fallen vacant on 4<sup>th</sup> June, 2019 by reason of his resignation; and

2. **WHEREAS**, a bye-election is required to be held for the purpose of filling the vacancy so caused;
3. **NOW, THEREFORE**, in pursuance of sub-section (I) of Section 150 and Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951 ), the Election Commission of India hereby:-
- A) **Calls upon** the said **224-Kharagpur Sadar Assembly Constituency** in the State of West Bengal, to elect, before the 30<sup>th</sup> November, 2019 (Saturday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person for the purpose of filling the said vacancy in the Legislative Assembly of the State; and
- B) **Appoints**, with respect to the said election: -
- (a) the 06<sup>th</sup> November, 2019 (Wednesday), as the last date for making nominations;
- (b) the 07<sup>th</sup> November, 2019 (Thursday), as the date for the scrutiny of nominations;
- (c) the 11<sup>th</sup> November, 2019 (Monday), as the last date for withdrawal of candidatures;
- (d) **the 25<sup>th</sup> November, 2019 (Monday), as the date on which a poll shall, if necessary, be taken;**
- (e) the 30<sup>th</sup> November, 2019 (Saturday), as the date before which the election shall be completed; **and**
- C) **Fixes the hours** from **07:00 AM to 06:00 PM** as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
