NOTIFICATION

No. 100/ECI/NOTI/TERR/ES-II/WB-LA/11/2019 :- WHEREAS, the seat of Shrimati Mahua Moitra, in the Legislative Assembly of the State of West Bengal, elected from 77-Karimpur Assembly Constituency has fallen vacant on 7th June, 2019 by reason of her resignation; and

2. **WHEREAS**, a bye-election is required to be held for the purpose of filling the vacancy so caused:
3. **NOW, THEREFORE**, in pursuance of sub-section (1) of Section 150 and Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby:
- A) **Calls upon** the said **77-Karimpur Assembly Constituency** in the State of West Bengal, to elect, before the 30th November, 2019 (Saturday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person for the purpose of filling the said vacancy in the Legislative Assembly of the State, and
- B) **Appoints**, with respect to the said election: -
- (a) the 06th November, 2019 (Wednesday), as the last date for making nominations;
- (b) the 07th November, 2019 (Thursday), as the date for the scrutiny of nominations;
- (c) the 11th November, 2019 (Monday), as the last date for withdrawal of candidatures;
- (d) **the 25th November, 2019 (Monday), as the date on which a poll shall, if necessary, be taken;**
- (e) the 30th November, 2019 (Saturday), as the date before which the election shall be completed; **and**
- C) **Fixes the hours** from **07:00 AM to 06:00 PM** as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
