NOTIFICATION

No. 100/WB-LA/01/2021:— WHEREAS, the seat of Shri Sobhandeb Chattopadhyay, in the Legislative Assembly of the State of West Bengal, elected from 159-Bhabanipur Assembly Constituency has fallen vacant on 21st May, 2021 by reason of his resignation; and

2. WHEREAS, a bye-election is to be held for the purpose of filling the said vacancy;

3. NOW, THEREFORE, in pursuance of sub-section (1) Section 150 and Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission hereby:—
- A. Calls upon the said 159-Bhabanipur Assembly Constituency in the State of West Bengal, to elect, before the 5th October, 2021 (Tuesday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person for the purpose of filling the said vacancy in the said Legislative Assembly Constituency; and
- B. Appoints, with respect to the said election: —
- a) the 13th September, 2021 (Monday), as the last date for making nominations;
- b) the 14th September, 2021 (Tuesday), as the date for the scrutiny of nominations;
- c) the 16th September, 2021 (Thursday), as the last date for withdrawal of candidatures;
- d) the 30th September, 2021 (Thursday), as the date on which a poll shall, if necessary, be taken;
- e) the 5th October, 2021 (Tuesday), as the date before which the election shall be completed; and
- C. Fixes the hours from 07:00 AM to 06:30 PM as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
