NOTIFICATION

No. 100/CS-WB/02/2021(1): – WHEREAS, the seat of Shri Dinesh Trivedi, in the Council of States, elected by the elected members of the Legislative Assembly of West Bengal, has become vacant on 12.02.2021 by the reason of his resignation, before the expiration of his term of office which was up to and including 02.04.2026; and

WHEREAS, a bye-election is to be held for the purpose of filling the vacancy so caused;

NOW, THEREFORE, in pursuance of Section 147, sub-section (1) of Section 39 and Section 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby—

- (A) **calls upon** the elected members of the Legislative Assembly of West Bengal to elect, before 10th August, 2021 and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person for the purpose of filling the said vacancy in the Council of States;
- (B) **appoints**, with respect to the said election:
- the 29th July, 2021 (Thursday), as the last date for making nominations;
 - the 30th July, 2021 (Friday), as the date for the scrutiny of the nominations;
 - the 02nd August, 2021 (Monday), as the last date for the withdrawal of candidatures;

- (d) the 09th August, 2021 (Monday), as the date on which a poll shall, if necessary, be taken; and
- (e) the 10th August, 2021 (Tuesday), as the date before which the election shall be completed; and
- (C) fixes the hours from 09:00 am to 04:00 pm**, as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
