NOTIFICATION

No. 100/ECI/NOTI/TERR/ES-II/WB-LA/2/2019: WHEREAS, the seat of Shri Satyajit Biswas in the Legislative Assembly of the State of West Bengal, elected from 88- Krishnaganj(SC) Assembly Constituency has fallen vacant on 09th February, 2019 by reason of his death; and

2. **WHEREAS**, a bye-election is required to be held for the purpose of filling the vacancy so caused;
3. **NOW, THEREFORE**, in pursuance of Sections 150, 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby:-
- (A) **calls upon** the said 88-Krishnaganj (SC) Assembly Constituency in the State of West Bengal, to elect, before the 27th May, 2019 (Monday) and in accordance with the provisions of the said Act and of the rules and order made thereunder, a person belonging to any of the Scheduled Castes of the State for the purpose of filling the said vacancy in the Legislative Assembly of the state;
- (B) **appoints**, with respect to the said election: –
- the 09th April, 2019 (Tuesday), as the last date for making nominations;
 - the 10th April, 2019 (Wednesday), as the date of scrutiny of nominations;
 - the 12th April, 2019 (Friday), as the last date for withdrawal for candidatures;
 - the 29th April, 2019 (Monday), as the date on which a poll shall, if necessary, be taken;
 - the 27th May, 2019 (Monday) as the date before which the election shall be completed; **and**
- (C) **fixes the hours** from **7:00 AM to 6:00 p.m.** as the hours during which the poll shall, if necessary, be taken on the date specified above for the bye-election.
