NOTIFICATION

No. 100/ECI/NOTI/TERR/ES-II/WB-LA/4/2019:— WHEREAS, the seat of Shri Abu Taher Khan in Legislative Assembly, elected from 74-Nowda Assembly Constituency in the State of West Bengal, has become vacant on 14th March, 2019 by reason of his resignation;and

2. **WHEREAS**, a bye-election is required to be held for the purpose of filling the vacancy so caused;
3. **NOW, THEREFORE**, in pursuance of sub-section (1) of Section 150 and Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby:—
- A) calls upon** the said **74-Nowda Assembly Constituency** in the State of West Bengal, to elect, before the 27th May, 2019 (Monday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person for the purpose of filling the said vacancy in the Legislative Assembly.
- B) appoints**, with respect to the said election:—
- (a) the 29th April, 2019 (Monday), as the last date for making nominations;
- (b) the 30th April, 2019 (Tuesday), as the date for the scrutiny of nominations;
- (c) the 2nd May, 2019 (Thursday), as the last date for withdrawal of candidatures;
- (d) **the 19th May, 2019 (Sunday), as the date on which a poll shall, if necessary, be taken;**
- (e) the 27th May, 2019 (Monday), as the date before which the election shall be completed; **and**
- C) fixes the hours** from **7.00 am to 6.00 pm** as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
