**NOTIFICATION**

No. 100/ECI/NOTI/TERR/ES-II/WB-LA/6/2019:— WHEREAS, the seat of Shri Apurba Sarkar in the Legislative Assembly of the State of West Bengal, elected from **68-Kandi Assembly Constituency** has become vacant on 14<sup>th</sup> March, 2019 by reason of his resignation; and

2. **WHEREAS**, a bye-election is required to be held for the purpose of filling the vacancy so caused;
3. **NOW, THEREFORE**, in pursuance of sub-section (1) of Section 150 and Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby:—
- A) calls upon** the said **68-Kandi Assembly Constituency** in the State of West Bengal, to elect, before the 27<sup>th</sup> May, 2019 (Monday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person for the purpose of filling the said vacancy in the Legislative Assembly.
- B) appoints**, with respect to the said election:—
- (a) the 29<sup>th</sup> April, 2019 (Monday), as the last date for making nominations;
- (b) the 30<sup>th</sup> April, 2019 (Tuesday), as the date for the scrutiny of nominations;
- (c) the 2<sup>nd</sup> May, 2019 (Thursday), as the last date for withdrawal of candidatures;
- (d) **the 19<sup>th</sup> May, 2019 (Sunday), as the date on which a poll shall, if necessary, be taken;**
- (e) the 27<sup>th</sup> May, 2019 (Monday), as the date before which the election shall be completed; **and**
- C) fixes the hours** from **7.00 am to 6.00 pm** as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
