M E M O R A N D U M

In connection with bye-election to **25-HOWRAH PARLIAMENTARY CONSTITUENCY** scheduled to be held on **2<sup>nd</sup> JUNE, 2013 (Sunday)**, the undersigned is directed to declare that as Sunday is a holiday under N.I. Act, 1881 all offices within the extent of the said P.C. should remain closed on that day i.e. on 2<sup>nd</sup> June, 2013 and the day of dispatch i.e. the day before the poll day (01.06.2013) may be declared as local holidays for the educational institutions located within the Parliamentary Constituency, if the day of dispatch happens to be a teaching day for those institutions.

The undersigned is further directed to say that the State Government employees who are ordinarily residents and bonafide electors of the Constituency where poll will be held may be given opportunity to exercise their franchise on the day of poll in the following manner.

- i) Those who are ordinarily residents and bonafide electors of the Constituency where poll will be held but serve in an office outside the constituency where the date of poll will not be declared as holiday may be given opportunity to exercise their franchise on that day by way of sanctioning late arrival in office or early departure there from or a short absence or special C.L. for those where it is not possible to exercise franchise by way of late arrival or earlier departure.
- ii) The undersigned is further directed to say that in the event of re-poll the State Government Employees who are ordinarily residents and bonafide electors of the polling station(s) where re-poll will be held may be given opportunity to exercise their franchise on the day of re-poll in the manner detailed as above.
