NOTIFICATION

No.100/WB-LA/1/2011: - Whereas, the Commission had vide its Notifications No.100/WB-LA/1/2011 dated 29th August, 2011 and No. 100/WB-LA/2/2011 dated 29th August, 2011 notified the programme for bye-election to the

State Legislative Assembly of West Bengal from 125- Basirhat Uttar and 159- Bhabanipur Assembly Constituencies respectively; and

Whereas, the Commission had also fixed hours of poll from **08:00 A.M to 05:00 P.M.** for the above-mentioned two Assembly Constituencies; and

Whereas, the Commission observed that in the recently concluded General Election to the State Legislative Assembly of West Bengal, 2011, the hours of poll in respect of above-mentioned two Assembly Constituencies were fixed from **07:00 A.M to 05:00 P.M.**

Whereas, the Commission considered it appropriate to follow the same hours of poll for the ensuing bye-elections from 125- Basirhat Uttar and 159- Bhabanipur Assembly Constituencies, and has accordingly fixed the hours of poll as **07:00 A.M to 05:00 P.M.**

Now, therefore, the Election Commission in exercise of the powers conferred on it under section 56 of the Representation of People Act, 1951 (43 of 1951) read with section 21 of the General Clauses Act, 1897, hereby makes the following amendments in its Notifications referred to above; namely:-

For the existing words and figures namely, "**08:00 A.M. to 05:00 P.M.**" in para 3(C) of both the Notifications namely 100/WB-LA/1/2011 dated 29th August, 2011 and 100/WB-LA/2/2011 dated 29th August, 2011, the words and figures "**07:00 A.M. to 05:00 P.M.**" shall be substituted.
