NOTIFICATION

No. 100/WB-LA/3/2014: WHEREAS, the seat of Shri Ajoy Dey in the Legislative Assembly of the State of West Bengal, elected from 86-Santipur-Nadia Assembly Constituency in the State, has become vacant on 11th December, 2013 by reason of his resignation; and,

2. WHEREAS, a bye-election is to be held for the purpose of filling the vacancy so caused;

3. NOW, THEREFORE, in pursuance of sub-section (1) of Section 150, and Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby—

- (A) Calls upon the said 86-Santipur-Nadia Assembly Constituency in the State of West Bengal, to elect, before the 28th May, 2014 (Wednesday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person, for the purpose of filling the said vacancy in the Legislative Assembly of the State;
- (B) appoints, with respect to the said election:—
- (a) the 24th April, 2014 (Thursday), as the last date for making nominations;
 - (b) the 25th April, 2014 (Friday), as the date for the scrutiny of nominations;
 - (c) the 28th April, 2014 (Monday), as the last date for the withdrawal of candidatures;
 - (d) the 12th May, 2014 (Monday), as the date on which a poll shall, if necessary, be taken;
 - (e) the 28th May, 2014 (Wednesday), as the date before which the election shall be completed; and
- (C) Fixes the hours from 7:00 AM to 6:00 PM, as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
