**NOTIFICATION**

No. 100/WB-LA/4/2014: WHEREAS, the seat of Shri Naresh Chandra Chaki in the Legislative Assembly of the State of West Bengal, elected from 91-Chakdaha, Nadia Assembly Constituency in the State, has become vacant on 24th February, 2014 by reason of his death; and,

2. WHEREAS, a bye-election is to be held for the purpose of filling the vacancy so caused;

3. NOW, THEREFORE, in pursuance of sub-section (1) of Section 150, and Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby—

- (A) Calls upon the said 91-Chakdaha, Nadia Assembly Constituency in the State of West Bengal, to elect, before the 28th May, 2014 (Wednesday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person, for the purpose of filling the said vacancy in the Legislative Assembly of the State;
- (B) appoints, with respect to the said election:—
- (a) the 24<sup>th</sup> April, 2014 (Thursday), as the last date for making nominations;
  - (b) the 25<sup>th</sup> April, 2014 (Friday), as the date for the scrutiny of nominations;
  - (c) the 28<sup>th</sup> April, 2014 (Monday), as the last date for withdrawal of candidatures;
  - (d) the 12<sup>th</sup> May, 2014 (Monday), as the date on which a poll shall, if necessary, be taken;
  - (e) the 28<sup>th</sup> May, 2014 (Wednesday), as the date before which the election shall be completed;  
and
- (C) Fixes the hours from 7:00 AM to 6:00 PM, as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
