**NOTIFICATION**

No. 100/WB-LA/7/2014: WHEREAS, the seat of Shri Narayan Mukherjee in the Legislative Assembly of the State of West Bengal, elected from 124-Basirhat Dakshin Assembly Constituency in the State, has become vacant on 10<sup>th</sup> April, 2014 by reason of his death; **and,**

2. WHEREAS, a bye-election is to be held for the purpose of filling the vacancy so caused;
3. NOW, THEREFORE, in pursuance of sub-section (1) of Section 150, and Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby:—
- a) calls upon the said 124-Basirhat Dakshin Assembly Constituency in the State of West Bengal, to elect, before the 19<sup>th</sup> September, 2014 (Friday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person, for the purpose of filling the said vacancy in the Legislative Assembly of the State:
  - b) appoints, with respect to the said election:—
    - (a) the 27<sup>th</sup> August, 2014 (Wednesday), as the last date for making nominations;
    - (b) the 28<sup>th</sup> August, 2014 (Thursday), as the date for the scrutiny of nominations;
    - (c) the 30<sup>th</sup> August, 2014 (Saturday), as the last date for withdrawal of candidatures;
    - (d) **the 13<sup>th</sup> September, 2014 (Saturday)**, as the date on which a poll shall, if necessary, be taken;
    - (e) the 19<sup>th</sup> September, 2014 (Friday), as the date before which the election shall be completed; and
  - c) Fixes the hours from 7:00 am to 6:00 pm, as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
