No. 576/3/EVM/2014/SDR(Bye-LA):— Whereas, Section 61A of the Representation of the People Act, 1951, provides that the giving and recording of votes by Voting Machines in such manner as may be prescribed, may be adopted in such constituencies as the Election Commission of India may, having regard to the circumstances of each case specify; and

2. Whereas, the Commission has considered the circumstances in **202-Nandigama(SC) Assembly Constituency in Andhra Pradesh, 9-Silchar, 13-Lakhipur & 90-Jamunamukh Assembly Constituencies in Assam, 79-Antagarh(ST)**

Assembly Constituency in Chhattisgarh, 13-Deesa, 53-Maninagar, 66-Tankara, 81-Khambhalia, 89-Mangrol, 100-Talaja, 112-Anand, 115-Matar & 131-Limkheda (ST) Assembly Constituencies in Gujarat, 26-Surajgarh, 75-Weir (SC), 102-Nasirabad & 190-Kota South Assembly Constituencies in Rajasthan, 15-Ranganj-Yangang Assembly Constituency in Sikkim, 39-Manu (ST) Assembly Constituency in Tripura, 3-Saharanpur Nagar, 22-Bijnour, 26-Thakurdwara, 61-Noida, 138-Nighasan, 173-Lucknow East, 228-Hamirpur, 231-Charkhari, 251-Sirathu, 282-Balha (SC) and 387-Rohaniya Assembly Constituencies in Uttar Pradesh, 124-Basirhat Dakshin & 162-Chowrangee Assembly Constituencies in West Bengal, and is satisfied that sufficient number of Electronic Voting Machines are available for taking the poll in the above mentioned Assembly Constituencies, the polling personnel are well trained in efficient handling of the Electronic Voting Machines and the electors are also fully conversant with the operation of the Electronic Voting Machines;

Now, therefore, the Election Commission of India hereby specifies **202-Nandigama(SC) Assembly Constituency in Andhra Pradesh, 9-Silchar, 13-Lakhipur & 90-Jamunamukh Assembly Constituency in Assam, 79-Antagarh(ST) Assembly Constituency in Chhattisgarh, 13-Deesa, 53-Maninagar, 66-Tankara, 81-Khambhalia, 89-Mangrol, 100-Talaja, 112-Anand, 115-Matar & 131-Limkheda(ST) Assembly Constituencies in Gujarat, 26-Surajgarh, 75-Weir(SC), 102-Nasirabad & 190-Kota South Assembly Constituencies in Rajasthan, 15-Ranganj-Yangang Assembly Constituency in Sikkim, 39-Manu (ST) Assembly Constituency in Tripura, 3-Saharanpur Nagar, 22-Bijnour, 26-Thakurdwara, 61-Noida, 138-Nighasan, 173-Lucknow East, 228-Hamirpur, 231-Charkhari, 251-Sirathu, 282-Balha (SC) and 387-Rohaniya Assembly Constituencies in Uttar Pradesh, 124-Basirhat Dakshin & 162-Chowrangee Assembly Constituencies in West Bengal**, as the constituencies in which the votes at the current bye-elections to the Legislative Assemblies of the said States **notified on 20.08.2014 (Wednesday)**, shall be given and recorded by means of Electronic Voting Machines in the manner prescribed under the Conduct of Elections Rules, 1961, and the supplementary instructions issued by the Commission from time to time on the subject.
