WHEREAS the power of requisitioning of premises, for election purposes, in connection with the bye-election held within the State is vested in the concerned State Government under Section 160 of the Representation of the People Act, 1951 and ;

WHEREAS the polls for the bye-election in Assembly Constituency 216 — Kanthi Dakshin in the district of Purba Medinipur is scheduled to be held on 09.04.2017 (Sunday) and Counting of Poll is scheduled to be held on 13th April, 2017(Thursday) and;

WHEREAS the Payment of compensation is to be made thereof under Section 161 of the said Act and;

WHEREAS the State Government may confer any of the powers/duties imposed on that Government to such specified Officers or class of Officers under Section 166 of the said Act;

NOW, therefore, the Government of West Bengal in the Land & Land Reforms Department, hereby, delegates the powers of requisitioning of premises to the District Election Officer, Purba Medinipur in respect of 216 — Kanthi Dakshin Assembly Constituency scheduled to be held during the aforesaid period, as mentioned under Section 160 of the said Act read with Election Commission of India's Press Note bearing No. ECI/PN/24/2017 dated 09.03.2017 and also the power of determination of rate of compensation and payment of compensation to be made under Section 161 of the said Act and the power to release the premises from requisition as per provision of Section 165 of the said Act.

The District Magistrate/District Election Officer shall be liable to discharge the duties conferred on them.
