ORDER

WHEREAS the Election Commission is satisfied that the contesting candidate specified in column (4) of the Table below at the General Election to Lok Sabha, 2014 held from the constituency specified in column (3) against his name has failed to lodge any account of his Election expenses as required by the Representation of the People Act, 1951, and the Rules made thereunder as shown in column (5) of the said Table;

AND WHEREAS, the said candidate has not furnished any reason or explanation for the said failure even after due notice of the Election Commission.

NOW, THEREFORE, in pursuance of Section 10A of the said Act, the Election Commission hereby declares the person specified in column (4) of the Table below to be disqualified for being chosen as and for being a member of either House of the Parliament or of the Legislative Assembly or Legislative Council of a State/Union Territory for a period of three years from the date of this order.
