NOTIFICATION

No. 100/ECE/LET-TERR-ES-II WB-LA 1/2017;—WHEREAS, the seat of Dr. Manas Ranjan Bhunia in the Legislative Assembly of the State of West Bengal, elected from 226-Sabang Assembly Constituency, has fallen vacant from 24th July, 2017 by reason of his resignation; and,

2. WHEREAS, a bye-election is required to be held for the purpose of filling the vacancy so caused:

3. NOW, THEREFORE, in pursuance of sub-section (1) of Section 150 and Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby:—

(A) Calls upon the said **226-Sabang Assembly Constituency** in the State of West Bengal, to elect, before the 26th December, 2017 (Tuesday) and in accordance with the provisions of the said Act and of the rules and order made thereunder, a person for the purpose of filling the said vacancy in the Legislative Assembly.

(B) appoints, with respect to the said election: —

- a) the 04th December, 2017 (Monday), as the last date for making nominations;
- b) the 05th December, 2017 (Tuesday), as the date of scrutiny of nominations;
- c) the 07th December, 2017 (Thursday), as the last date for withdrawal of candidature;
- d) the 21st December, 2017 (Thursday), as the date on which a poll shall, if necessary, be taken;**
- e) the 26th December, 2017 (Tuesday), as the date before which the election shall be completed; and

(C) fixes the hours from **7:00 AM to 5:00 PM**, as the hours during which the poll shall, if necessary, be taken on the date specified above for the bye-election.
