NOTIFICATION

No. 100/WB-LA/01/2024 :- WHEREAS, the seat of Shri Idris Ali, in the Legislative Assembly of the State of West Bengal, elected from 62-Bhagawangola Assembly Constituency has fallen vacant on 16th February, 2024 due to his sudden demise; and

2. WHEREAS, a bye-election is to be held for the purpose of filling the said vacancy;
 3. NOW, THEREFORE, in pursuance of sub-section (1) of Section 150 and Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission hereby:—
 - A. calls upon the said 62-Bhagawangola Assembly Constituency in the State of West Bengal, to elect, before the **6th June, 2024 (Thursday)** and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person for the purpose of filling the said vacancy in the said Legislative Assembly Constituency; and
 - B. appoints, with respect to the said election: —
 - a) the 19th April, 2024 (Friday), as the last date for making nominations;
 - b) the 20th April, 2024 (Saturday), as the date for the scrutiny of nominations;
 - c) the 22nd April, 2024 (Monday), as the last date for withdrawal of candidatures;
 - d) the 7th May, 2024 (Tuesday), as the date on which a poll shall, if necessary, be taken;
 - e) the 6th June, 2024 (Thursday), as the date before which the election shall be completed; and
 - C. fixes the hours from 07:00 AM to 06:00 PM as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
