Jos Thomas, Director, Parliament of India, No. H=11021/11/2015-Leg.II Government of India Ministry of Law and Justice Legislative Department, Shastri Bhawan New Delhi, dated the 28 July,2015, of my petition Ref.No.404/AITUP/15, dated 02-05-2015, to the Hon'ble Prime Minister of India, and I also promulgated for the same to the Nation as my Smarak Patra No.406/AITUP/15, dated 01-09-2015.
